### DEMOLITION DERBY

#### General Rules & Regulations

In the interest of safety anyone entering is subject to, and must obey the following rules and regulations, which are set up by the promoter and the track where this event is being held.

1. a. Each driver must fill out an entry form and sign a waiver of liability, which must be mailed, dropped off or faxed to the DAS Office by the deadline on the entry form.  
  
b. Entry fees, payable at the DAS Office, will be accepted up until 8 p.m. Wednesday prior to the fair. If an entry must be cancelled, fees will be refunded providing the DAS office (745-2226) is notified prior to noon on Saturday.
2. The track or promoter reserves the right to approve or reject any and all entries.
3. **Only the driver and two pit crew members who sign the release sheet will be permitted in the pit area. No horseplay or drinking in pit area.**
4. **ABSOLUTELY NO DRINKING OF ALCOHOL ON THE TRACK OR IN PIT AREA.** Violators will be removed and their team disqualified.
5. All cars will be inspected before the demo. Winning cars will be inspected after the demo heat. Any reinforced cars will be disqualified.
6. Cars must be in the pit area by 12:00 noon for inspection.
7. Drivers, male, or female must be 18 or older. **NO ONE UNDER THE AGE OF 18** will be allowed in the pit area.
8. **Any driver, pit crewmember, or person found not obeying the rules and regulations will cause disqualification of the car. NO REFUND.**

9. Drivers must carry two flags: one white and one red. These flags will be supplied when you sign in.

WHITE FLAG- Out of Demolition

RED FLAG – Stop Demolition

10. Drivers may maneuver forward or backward. NO DELIBERATE HITTING ON THE DRIVER'S DOOR. This rule will be enforced.
11. The judges will announce a time limit of one minute. If a driver does not hit another live car within the limit, he or she may be disqualified. Playing "possum" will lead to disqualification.
12. Pit boundaries must be observed and will be enforced.
13. Any car catching on fire twice is automatically disqualified if unable to start and continue within one minute.
14. If a car catches fire, all other cars must stop.
15. Remaining TWO cars from the individual heats are allowed in the "feature heat".
16. All entries shall be in the demo pit before the beginning of all heats.
17. **Drivers must proceed with caution at all times, or risk being disqualified.**
18. NO GANGING UP. The derby committee has the right to make a judgment call. Do not avoid making a hit on your buddy just so that you can eliminate a chosen car. Do not hold a car until your buddy is in a position to hit it. **Any discussion on the matter should be held at the drivers meeting prior to the start of the derby.**
19. For safety and crowd control, PLEASE NO FAMILIES OR EXTRA HELP in the pit area. Your co-operation would be greatly appreciated.
20. All cars must be removed from the grounds within 3 hours after the demo derby or cars will become the property of the promoter.
21. **All decisions of the Demo Derby committee are final.**

## Checklist

- Number on car
- All Glass Removed (WIndsheild Optional)
- Screen on Drivers Door Window
- Gas Tank Removed or ahead of rear axle behind front seat.
  - fastened securly
- 
- 1-12 volt battery fastened securely and covered.
- Reinforced bumpers –Tie Rods & trailer hitch removed.
- Doors Fastened
- Suspension must be free
- Hood & trunk must be operable but must be chained. **NO BOLTS**
- Brakes
- Car interior must be clean
- No extra weight
- Rad in original position
- Hole in hood above carburetor
- Fire extinguisher
- Seat belt
- Helmet
- Hole in roof
- Red & white flags
- Two door cars – crossbar behind seat is permissible, not mandatory.
